### **Vendor Space Exhibitors:**

***The 2019 Moose Jaw Hometown Fair will be held – June 21<sup>st</sup>, 22<sup>nd</sup>, and 23<sup>rd</sup>, 2019.***

Upon Arrival the Moose Jaw Exhibition Co. will position vendors at their discretion.

- All fees are subject to GST
- Please notify the office if you have any special requirements in your designated area (any additional costs will be your responsibility)
- All electrical cords and electrical hook ups are subject to approval by Regal Electric
- All cancellations must be submitted in writing to the Moose Jaw Exhibition Company LTD Administration Office by 5:00pm May 17<sup>th</sup>, 2019. **Any cancellations after this date will result in the forfeit of all fees.**

### **Exhibitor's Insurance Requirements**

It is required that every Exhibitor/Lessee meets all fire, health and any other related provincial regulations: liability, public liability, theft, fire and other coverage is recommended and may be required. This will be left to the discretion of the Moose Jaw Exhibition Company.

The Lessee will obtain and keep in force during the term of occupation, Comprehensive General Public Liability insurance respecting the use, occupancy and conduct of business in accordance with the Lessor's minimum insurance requirements, with insurers acceptable to the Lessor (Moose Jaw Exhibition Company Ltd.), for the amount not less than \$2,000,000.00. The policy will name the Moose Jaw Exhibition Company as an additional named insured with the cross-liability clause and the Lessee shall promptly furnish to the Lessor, copies of insurance policies or other applicable documentation by **May 17<sup>th</sup>, 2019**. Failure to do so will result in termination of the contract and the forfeit of all rental fees.

**All Booths and Trailers must remain open until 10:00pm Sunday June 23<sup>rd</sup> 2019 (unless otherwise specified), and must be removed by 11:59 PM Sunday June 23<sup>rd</sup> 2019. Failure to remove your items from the grounds will result in the forfeit of Performance Bond.**
