The 2019 parade is being organized by the Moose Jaw Exhibition Company. This years theme will be “**Candy Land**” so please dress or decorate in colorful candy themed attire and floats! **The parade this year will be held on Thursday June 20th, 2019 at 7:00pm. Due to rising costs to host the parade we will require a \$25 entry fee per float paid with your application. Prizes will be awarded to the best three floats that follow the theme.**

Participants will need to be at the old Zellers parking lot in the Town-N-Country Mall parking lot no later than 6:40pm, unless told otherwise. The parade will begin at 7:00pm. The Parade begins at the corner of Saskatchewan Street and follows south on Main Street and ending at Manitoba Street. We advise you to enter the Town N Country Mall parking lot at the north end where the traffic lights are.

Parade Rules

- All participants in parade **must** have a signed application.
- Entries must be received by the deadline of **June 7th 2019**.
- We encourage everyone to follow the theme we have set.
- Understand that under **NO CIRCUMSTANCES** may you park in the **Civic Centre Plaza** parking lots.
- Groups/Businesses/Organizations wishing to submit multiple entries must submit a new separate application form for each entry. **The maximum is 3 entries per group/organization/business.**
- City Bylaws state **nothing can be thrown from vehicles/floats to avoid injuries**. Hand-outs must be given by walking participants. Water guns are prohibited.
- You will receive confirmation by June 14th, 2019. If you do not receive confirmation please contact the Moose Jaw Exhibition Company administration office and ask for Kennedy.
