

# 2024 MOOSE JAW HOMETOWN FAIR PARADE

The parade will be held on Thursday, June 20th, 2024 at 7:00 pm, commencing on Town and Country Drive, merging on to Saskatchewan Street East and proceeding to Main Street heading South, and concluding at Manitoba Street. The parade is considered complete for **ALL** participants of the parade once they reach Manitoba Street meaning that you **must obey** all traffic signs. Due to rising costs to host the parade, there will be a **\$25 registration fee** per application.
